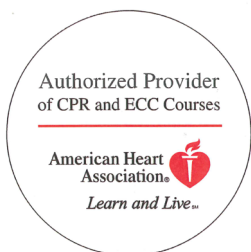

The Advanced Cardiac Life Support (ACLS) Initial and Recertification Provider courses is designed for healthcare providers who either direct or participate in resuscitation of a patient, in or out of the hospital setting. The goal of the ACLS Provider course is to improve the quality of care provided to the adult victim of a cardiac arrest or other cardiopulmonary emergency. Students will practice the application of these and other skills in simulated cases, and will practice both team leader and team member roles.

Audience

Physicians, nurses, pre-hospital emergency personnel, respiratory therapists, dentists, and other professionals who may respond to a cardiovascular emergency

Objectives

- Recognize early management of peri-arrest conditions that may result in cardiac arrest or complicate resuscitation outcome
- Initiate early management of peri-arrest conditions that may result in cardiac arrest or complicate resuscitation outcome
- Demonstrate proficiency in providing BLS care, including prioritizing chest compressions and integrating AED use
- Manage cardiac arrest until the return of spontaneous circulation, transfer of care, or termination of resuscitation
- Identify ischemic chest pain and treatment strategies
- Expedite the care of patients with acute coronary syndromes
- Recognize other life-threatening clinical situations, such as stroke and what effective initial care and transfer criteria are needed to reduce disability and death
