The Advanced Cardiovascular Life Support (ACLS) Initial and Recertification Provider course is designed for healthcare providers who either direct or participate in resuscitation of a patient, in or out of the hospital setting. The goal of the ACLS Provider course is to improve the quality of care provided to the adult victim of a cardiac arrest or other cardiopulmonary emergency. Students will practice the application of these and other skills in simulated cases, and will practice both team leader and team member roles.

OBJECTIVES

- Recognize early management of peri-arrest conditions that may result in cardiac arrest or complicate resuscitation outcome
- Initiate early management of peri-arrest conditions that may result in cardiac arrest or complicate resuscitation outcome
- Demonstrate proficiency in providing BLS care, including prioritizing chest compressions and integrating AED use
- Manage cardiac arrest until the return of spontaneous circulation, transfer of care, or termination of resuscitation
- Identify ischemic chest pain and treatment strategies
- Expedite the care of patients with acute coronary syndromes
- Recognize other life-threatening clinical situations, such as stroke and what effective initial care and transfer criteria are needed to reduce disability and death

REGISTRATION

From I-40 Westbound, take Exit 50B and merge onto Hendersonville Road.

From 19-23 (I-26) take 240 East to Exit 5B (Charlotte Street). Exit right onto Charlotte Street. At the 4th light, make a left onto Biltmore Avenue. Proceed through 8 traffic lights.
