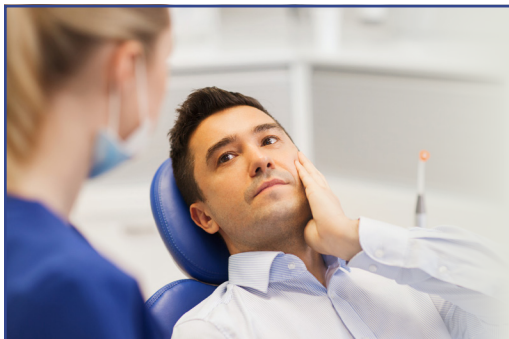


Treating Pain More Safely for Dental Healthcare Providers

Western North Carolina has been hit particularly hard by the opioid epidemic, which includes heroin, other illicit drugs and prescription pain medications. In 2014, 17 of 23 Western NC counties ranked among the top in the state in the rate of fatal overdoses—more than 20 deaths for every 100,000 residents. Statewide data also shows that all but five counties in the region have higher-than-average rates of opioid pills prescribed per person, particular in counties near the Tennessee border. Learn about this epidemic in our region, steps to take to perform safe opioid prescribing, ways to manage patients with potential drug seeking behaviors, and consider safer alternatives for treating dental pain following dental procedures.

This one-hour lecture/discussion will meet the annual controlled substance prescribing practice and controlled substance prescribing for chronic pain management continuing education requirement for dentists' license renewal in 2018 by the NC State Board of Dental Examiners.
