DESCRIPTION

Mental health and addiction specialists will share current information addressing addiction and affirmative treatment of the LGBTQ community, how cybersex addiction is affecting the participant and the impacted partners and family, and processes for improving therapy and treatment methods for individuals. Additionally, topics will include an inspection of the psychological testing categories and their application in providing care; and a review of the potentially risky medications in the treatment of co-occurring disease.

CONFERENCE FACULTY



Barbara Bennett, MSN, RN, LNC, CARN-AP, LCAS, oversees Pavillon's daily operations as Chief Operating Officer (COO). She was most recently the Executive Director of the NC Caring Dental Professionals Program—a state-wide advocacy and monitoring program for dental professionals. Previously, Ms. Bennett was the administrator over a behavioral services division with a healthcare system, providing a full continuum of substance use and psychiatric services. Her career includes 10 years of teaching in higher educational venues at the University of Kentucky and Western Carolina University. She has several articles and chapters published in refereed health journals, books, and clinical publications. Currently, Ms. Bennett serves as the President of the North Carolina Chapter of the International Nurses Society on Addictions. She is a Certified Addictions Registered Nurse Advance Practice (CARN-AP) nurse and also a Licensed Clinical Addictions Specialist (LCAS) in North Carolina.



Brian Coon, MA, LCAS, CCS, MAC, is Pavillon's Director of Clinical Programs. His duties include direction of the evaluation and treatment of the medical, legal, and other professionals served at Pavillon; development of organization-wide clinical programming; clinical staff education; internal and external training; outcome evaluation; research; and publication. Brian leads pre-admission clinical coordination and approval for admissions to Pavillon's residential programs.

Furthermore, he is responsible for the development and integration of the use of technology within Pavillon's clinical services.



Before coming to Pavillon, **Denise Kagan, PhD**, served as a psychologist at the Menninger Clinic's Professionals in Crisis Unit, as well as an Assistant Professor of Psychiatry at the Baylor College of Medicine in Houston, TX, where she supervised post-doctoral students. Her work at Menninger involved team-based milieu therapy for professionals who struggle with psychiatric impairments and addictions. Dr. Kagan received her master's and doctoral degrees at Adelphi

University in Garden City, NY in clinical psychology. She interned at North Shore University Hospital in Manhasset NY and she completed pre-doctoral fellowships at both SUNY-Downstate in Brooklyn, NY and Harvard Vanguard Medical Associates in Boston, MA before completing a four-year post-doctoral fellowship at the Austen Riggs Center in Stockbridge, MA. Her post-doctoral training focused intensively on psychodynamic psychotherapy, family and group systems, psychological assessment, and therapeutic milieu treatment with patients considered "treatment resistant." She is a member of the American Psychological Association.



Philip T. McCabe, CSW, CAS, CDVC, is a Certified Social Worker and a Nationally Certified Addiction Specialist in the areas of compulsive gambling, alcoholism, tobacco, other drugs, and sex addiction. He is a Health Educator for Rutgers School of Public Health, and an instructor for Robert Wood Johnson Medical School and Rutgers School of Nursing. He provides training on cultural competency and working with lesbian, gay, bisexual, and transgender individuals.



Sarah B. McGuire, LISW-CP, CSAT, EMDR, and **Leslie Hull-Kimball, LISW-CP, CSAT**, co-founded Upstate Recovery Center in 2014. Both Ms. McGuire and Ms. Hull-Kimball graduated from the University of South Carolina in 2001 with a Master's degree in Social Work. They are both Licensed Independent Social Workers—

Clinical Practice, Certified Sex Addiction Therapists, and social work supervisors. With over 35 years of combined clinical experience, Ms. McGuire and Ms. Hull-Kimball provide individual, family, couples, and group therapy for adolescents and adults. They also offer educational trainings and consultations for religious institutions, businesses, non-profit organizations, and educational institutions.



John Roberts, MD, is the Medical Director and Addiction Psychiatrist for Pavillon. He came to Pavillon with nearly 20 years of experience serving as an Assistant Professor of Psychiatry at the Medical University of South Carolina. While there, he was the attending psychiatrist for the inpatient dual diagnosis inpatient unit and was the director of the clinical outpatient division for the Center for Drugs and Alcohol Program. He received his doctor of medicine from Louisiana State University

and completed his psychiatric residency, as well as fellowships in substance abuse and anxiety disorders, at the Medical University of South Carolina. Dr. Roberts is board certified in psychiatry and has lectured throughout the Southeast on both substance use and psychiatric disorders.
