Physical Therapy: MAHEC, as part of the NC AHEC system, is a NCBPTE-approved provider of continuing competence for activities directly related to physical therapy. 5.0 Day One; 3.0 Day Two, 8.0 for both days.

Occupational Therapist/ Assistant: As of July 1, 2018, the NCBOT no longer accepts applications for pre-approval of CCAs. OT practitioners need to make sure they are completing activities that comply with Section .0800 of the NCBOT Rules. 5.75 CCAs for day one; 3.0 CCAs for day two; 8.75 CCAs for both days. Please select contact hours for your certificate.

Speech-Language Pathology: MAHEC will issue Certificates of Completion only; the participant must self-track and record the certificate for ASHA Certification documentation. Up to 5.75 hours for day one; up to 3.0 hours for day two; 8.75 hours for both days.

Psychologists: MAHEC is recognized by the North Carolina Psychology Board as an approved Provider of Category A Continuing Education for North Carolina Licensed Psychologists. 5.75 hours on day one; 3.0 hours on day two; 8.75 for both days Category A. Full attendance is required to receive credit.

North Carolina Social Work: The North Carolina Social Work Certification and Licensure Board does not require preapproval of organized training events. 5.75 on day one; 3.0 on day two; 8.75 for both days.

North Carolina Licensed Counselors: North Carolina Licensed Counselors may turn in up to 15 hours of continuing education annually from an AHEC. 5.75 hours on day one; 3.0 hours on day two; 8.75 hours for both days.
