Vulvar diseases can be frustrating for both patients and providers because they are often a complex mix of several problems. The goal of the morning program is to provide education and training in conservative methods of treating common vulvar conditions in the outpatient setting. Conditions include: dermatoses, vulvodynia, and Bartholin's gland abnormalities.

The first trimester of pregnancy can also be a vulnerable time, especially for women with a suspected abnormally developing pregnancy. The goal of the afternoon program is to provide education and training in the diagnosis and management of early abnormal pregnancies, and to provide training in manual vacuum aspiration, which can be performed in the outpatient setting for women with miscarriage.
