SESSIONS

Perinatal Substance Use Disorders 101 Wednesday, March 3, 2021 | 6:00-7:00

Substance use disorders in pregnancy are a major national public health concern. The rates of opioid use disorders (OUDs) are rising significantly and disproportionately in rural, southern women. This course provides an outline of the basics of substance use disorders/ addiction and how they differ in women and during pregnancy, as well as information on medication assisted therapy (MAT) in pregnancy and postpartum needs/barriers for continuation of care. Resources specific to Western North Carolina will also be discussed.

Coping with Perinatal Anxiety: Strategies for ensuring patients get access to quality mental health care Tuesday, March 16, 2021 | 6:00-7:00 Mary Kimmel, MD

Anxiety during the pregnancy and postpartum periods is thought to be even more common than perinatal depression, but it is rarely diagnosed and treated. Increased stress regarding employment, securing childcare, and access to resources in light of the COVID-19 pandemic have made the problem even more salient for health care providers and their patients. In this session, providers will learn practical skills for helping perinatal patients who are struggling with stress and anxiety, including brief intervention tools, medication management, and securing appropriate mental health resources in their region.

FACULTY

Melinda Ramage, MSN, FNP-BC, CARN-AP, is the Medical Director and Co-Founder of Project CARA (Care that Advocates Respect, Resilience, and Recovery for All). Project CARA provides comprehensive substance use treatment within a high-risk obstetrical care program at the Mountain Area Health Education Center (MAHEC) and has served over 700 patients since its inception in 2014. This program works with the direct support of a team of community partners that include comprehensive mental health, outreach programs, and hospital care services.

In addition to co-founding Project CARA, Ramage is a public speaker and clinical educator on perinatal substance use treatment, opioid use disorders, as well as prevention and awareness efforts in Western North Carolina and across the state.

Mary Kimmel, MD, is an Assistant Professor, Medical Director of NC Maternal Mental Health MATTERS program, and Co-Director of UNC's Perinatal Psychiatry Program.

The NC Maternal Mental Health MATTERS program provides education and support to frontline providers in the care of their pregnant and postpartum patients through screening, assessment, and treatment of stress, anxiety, depression, and other behavioral health disorders. Dr. Kimmel's research studies the relationship of the microbiota-gutbrain axis, stress reactivity, and tryptophan/serotonin metabolism. She focuses on how these affect pregnancy and the postpartum period in relation to the development of maternal depression and anxiety and the child's psychological development.

Lisa Carroll, MD, is a Maternal-Fetal Medicine Specialist. She joined the MAHEC Maternal-Fetal Medicine division in 2020 after completing Medical School at the University of North Carolina, Ob/Gyn Residency at Boston Medical Center, and MFM Fellowship at the University of California, Irvine. Throughout her training and career, Dr. Carroll's clinical and research interests have been guided by her commitment to social justice and equity for marginalized populations.

Dr. Carroll specializes in providing care for women who are 'at risk' and considering pregnancy, or those who are experiencing 'high-risk' or complicated pregnancies for a variety of reasons. Dr. Carroll sees patients who are undergoing diagnostic or therapeutic procedures such as comprehensive ultrasound, chorionic villus sampling and genetic amniocentesis. She also consults with patients who have medical and surgical disorders coincident with or prior to pregnancy, which includes heart disease, chronic hypertension, diabetes/other endocrinologic disorders, kidney/gastrointestinal diseases, and infectious diseases. Otherwise healthy women who may require these services are those whose pregnancies are at markedly increased risk for adverse outcomes, such as those with abnormal serum screens, multiple gestations, recurrent preterm labor, premature rupture of membranes or growth abnormalities of the fetus. Dr. Carroll considers it a great privilege to walk with women through questions and complications that arise in pregnancy in effort to achieve the healthiest possible outcomes for women and their growing families.
