In the United States, the number of people suffering with mental illness and substance use disorders is at a record high (SAMHSA, 2013). Community faith leaders are commonly turned to as initial support for those coping with mental health or substance use disorders. Clergy are charged with helping individuals with a variety of mental health symptoms, including anxiety, depression and substance use. Those with more severe issues are more often turning to clergy when appropriate services are not available.

There is little guidance for how clergy should respond to these needs, causing increased stress on faith leaders. This training will provide instruction on:

- Basic mental health education on the signs and symptoms
- Skills to overcome barriers to mental health and substance use treatment
- · Skills to assist clergy in coping with crises
- Clergy scope of practice and the need for referral
- Identifying internal and external church resources

AUDIENCE

The audience for this training is specific to clergy who are on the front lines of this need; however, lay people who serve in ministerial or leadership roles in the church may also benefit.

OBJECTIVES

Upon completion of this course, participants will be able to:

- Identify the signs and symptoms of mental illness
- Identify appropriate crisis response
- · Identify their scope of practice
- Identify the available community resources for appropriate referrals and collaboration for whole person care
- Determine when/how/where to refer congregants for additional support and the perimeters of the expectations of their role as a faith leader
- Develop support systems in the church to assist in aiding the mentally ill in connecting to community mental health and other services

Monica's diverse professional background has also provided her with executive leadership experience as the social work manager over 14 dialysis centers from Greensboro to Charlotte and as the behavioral health manager of a FQHC with seven sites across the Piedmont. In these posts, she focused on quality improvement and honed her professional skills in writing, executing, and managing federal and community foundation grants.
