DESCRIPTION

This comprehensive course encourages a standardized team-based approach amongst physicians, residents, nurse midwives, registered nurses, and other members of the maternity care team to improve patient safety and positively impact maternal outcomes.

AUDIENCE

This course is primarily directed toward maternity care providers including physicians, nurses, and certified nurse midwives, residents, students, EMS, EMTs, and Paramedics.

OBJECTIVES

- Discuss methods of managing pregnancy and birth urgencies and emergencies, which standardizes the skills of practicing maternity care providers
