DESCRIPTION

SBIRT is a comprehensive, integrated, public health approach to the delivery of early intervention and treatment services for persons with substance use disorders, as well as those who are at risk of developing these disorders. Primary care centers, behavioral health practices, hospital emergency rooms, trauma centers, and other community settings provide opportunities for early intervention with atrisk substance users before severe consequences occur.

This course offers participants an evidence-based protocol for quickly assessing the severity of substance use, offering effective brief interventions, and making appropriate referrals to treatment. Join us for a lively workshop offering more tools for your important work.

Learning methods include:

- Interaction and discussion
- Didactic presentation
- Sample videos
- Small group exercises with coaching and feedback

REGISTRATION

Early registration deadline: June 14, 2018

The above fees include administrative costs, educational materials, light breakfast, and lunch. If registration is received after the deadline, the total fee will be the registration fee + \$15.00.

MAHEC has a pay-up-front policy for all CE programs. The only exceptions will be for pre-approved programs where an individual payment plan is appropriate. Registrations received without accompanying payment will not be processed and participants who have not paid the course fee will not be admitted into the program.

From I-40 W: Take Exit 50B, merge on Hendersonville Rd.

From 19-23 (I-26): Take 240 East to Exit 5B (Charlotte Street). Exit right onto Charlotte Street. At the 4th light, make a left onto Biltmore Avenue. Proceed through 8 traffic lights. At the 9th light, turn right into the DoubleTree Hotel complex. Turn left (away from the hotel). You will see a steep driveway on your right. Turn right up that driveway to the MAHEC Biltmore Campus.
