DESCRIPTION

Pediatric Advanced Life Support (PALS) is a videobased, instructor-led course that uses simulated pediatric emergencies to reinforce the important concepts of a systemic approach to pediatric assessment, basic life support, PALS treatment algorithms, effective resuscitation, and team dynamics.

The goal of the PALS course is to improve the quality of care provided to seriously ill or injured children, resulting in improved outcomes.

From 19-23 (I-26): Take 240 East to Exit 5B (Charlotte Street). Exit right onto Charlotte Street. At the 4th light, make a left onto Biltmore Avenue. Proceed through 8 traffic lights. At the 9th light, turn right into the DoubleTree Hotel complex. Turn left (away from the hotel). You will see a steep driveway on your right. Turn right and go up that driveway to the MAHEC Biltmore Campus.
