	OBJECTIVES				

Pediatric Advanced Life Support (PALS) is a video-based, instructor-led course that uses simulated pediatric emergencies to reinforce the important concepts of a systematic approach to pediatric assessment, basic life support, PALS treatment algorithms, effective resuscitation and team dynamics. The goal of the PALS course is to improve the quality of care provided to seriously ill or injured children, resulting in improved outcomes.

REGISTRATION

Early registration fee for in-person, group PALS is \$225.00. If registration is received within seven days of the program, the total fee is \$240.00. The registration fee is waived for MAHEC employees.

Registrations received without accompanying payment will not be processed and participants who have not paid the course fee will not be admitted into the program.

From I-40 Westbound, take Exit 50B and merge onto Hendersonville Road.

At the first light, turn left into the DoubleTree Hotel complex. Turn left (away from the hotel). Before the Hampton Inn, turn right and proceed up the driveway Turn right into the MAHEC Biltmore Campus parking lot.

From 19-23 (I-26) take 240 East to Exit 5B (Charlotte Street). Exit right onto Charlotte Street. At the 4th light, make a left onto Biltmore Avenue. Proceed through 8 traffic lights. At the 9th light turn right into the DoubleTree Hotel complex. Turn left (away from the hotel). Before the Hampton Inn, turn right and proceed up the driveway Turn right into the MAHEC Biltmore Campus parking lot.
